Objectives:

- 1. To strengthen the relationship amongst the PV, Clinical Development and Regulatory areas and to provide a holistic understanding of the product's life cycle with the interlinkages between the three Departments.
- 2. To build on the areas identified collectively by the teams at the Joint DCVMN CDMA / PV Working Group Meeting June 2022, including the gaps, responsibilities of each area and mitigation activities covering the whole vaccine product life cycle (ie. pre licensure /clinical development) and post-licensure activities).
- 3. To build on best practice concepts for preparing regulatory documents (i.e. the Common Technical Document CTD and WHO PQ Dossier, Post-approval changes, safety processes and documents, a.o. as appropriate)

Deliverables:

- 1. Roadmap of interdepartmental workflows, SOPs and essential documents.
- A common harmonized action plan of the problems identified (i.e. implementation of Collaborative registration procedure (CRP), harmonized PAC guidance, and a first draft on action plan for regulatory reliance among NRAs for faster evaluation of post-approval changes).
- 3. Create a "Wishlist" for regulators to accelerate licensure (pre and post) filing / submission time as well as for CRP and PAC for subsequent publication.
